WHEREAS, on July 21, 2010, the Secretary of State issued a Temporary Order of Prohibition ("the Notice") of Hearing to Respondents wherein it was alleged that certain activities or business or sales practices conducted by Respondent violated Sections 12 A, 12 B and 12 D of the Illinois Securities Law of 1953 [815 ILCS 5/1] (the "Act")

WHEREAS, on August 24, 2010, the Secretary of State issued a Notice ("the Notice") of Hearing to Respondents, pursuant to their Section 11(F)(2) request for a hearing wherein it was alleged that certain activities or business or sales practices conducted by Respondent violated Sections 12 A, 12 B and 12 D of the Illinois Securities Law of 1953 [815 ILCS 5/1] (the "Act").

Order to Vacate Temporary Order of Prohibition


