This matter having come on for consideration before Jesse White, Secretary of State, through his designated representative, the Securities Director, and having been fully advised in the premises by the staff of the Illinois Securities Department, Office of the Secretary of State (the "Department"), the Secretary of State herein finds:

1. That at all times relevant, the Respondent Victoria Renois McGee-Harris, CRD#1183259 (hereinafter, "Respondent"), was registered as an Illinois securities salesperson through Tower Square Securities, Inc., pursuant to Section 8 of the Illinois Securities Law 815 ILCS 5/1 et seq. (the "Act") and the Respondent's salesperson registration was terminated in Illinois on February 11, 2010;



2. That on March 2, 2010, the Illinois Secretary of State entered an Order of Prohibition and Suspension (hereinafter, "Order") which permanently prohibited Respondent Victoria Renois McGee-Harris from offering and selling securities in the State of Illinois and permanently suspended the Illinois securities salesperson registration of Respondent Victoria Renois McGee-Harris.
3. That Section 8.E(2) of the Act provides, inter alia, that if the Secretary of State finds that any registrant has ceased to do business as a securities salesperson, the Secretary of State may by order cancel the registration of said registrant;
4. That as a result of the aforesaid termination of salesperson registration and Order of Prohibition and Suspension, the Department has determined that the Respondent has ceased to do business as a securities salesperson in the State of Illinois;
5. That it is in the public interest to enter an order which cancels the securities salesperson registration of the Respondent in the State of Illinois.

NOW THEREFORE IT IS HEREBY ORDERED: That the securities salesperson registration of Respondent Victoria Renois McGee-Harris in the State of Illinois is hereby cancelled.
