- 2. Respondent is licensed by the Illinois Department of Securities, Secretary of State as a salesperson of TD Ameritrade, Inc.

COUNT I

FAILURE TO PAY ANY TAX, PENALTY, OR INTEREST ADMINISTERD BY THE ILLINOIS DEPARTMENT OF REVENUE

- 3. Respondent failed to pay the final assessment of a tax administered by the Illinois Department of Revenue
- 4. Previously, the Department of Revenue has sent Respondent a <u>Collection Action</u> and Notice of Intent of Suspension of Your Salesperson License or Investment Adviser License (or Both).
- 5. To date, the tax referenced in paragraph 4 remains unpaid
- 6. That Section 8.E(1)(0) of the Act provides, inter alia, that the registration of an investment advisor representative or a salesperson may be suspended if the Secretary of State finds that such investment advisor representative or salesperson has failed to file a return, or to pay the tax, penalty or interest shown in a filed return, or to pay any final assessment of tax, penalty or interest, as required by any tax Act administered by the Illinois Department of Revenue, until such time as the requirements of that tax Act are satisfied.
- 7. By virtue of the foregoing, Respondent registration as a registered salesperson is subject to a revocation.
