ORDER OF CANCELLATION

This matter having come on for consideration before JESSE WHITE, Secretary of State, through his designated representative, the Securities Director, and having been fully advised in the premises by the staff of the Illinois Securities Department, Office of the Secretary of State, (the "Department") herein finds:

1. That K.W. Brown Investments (the "Respondent") is now and at all times relevant hereto was registered as a dealer in the State of Illinois pursuant to Section 8 of the Illinois Securities Law [815 ILCS 5/1 et seq.] (the "Act").
2. That the Respondent's registration as a dealer was revoked by the United States Securities and Exchange Commission ("SEC") on June 24, 2008.
3. That the Respondent's membership in the Financial Industry Regulatory Authority ("FINRA"), a self-regulatory organization, was Cancelled-NO SEC REGISTRATION on July 29, 2008.
4. That a representative of the Department attempted to telephone the Respondent on July 29, 2008. The call was placed to the Respondent's contact number as listed in the records of the Central Registration Depository ("CRD"). The Department's representative was advised by an individual who answered the telephone that the correct number was reached, but the Respondent was not associated with this telephone number.
5. That a contemporaneous check with Directory Assistance for the same area code as the Respondent's CRD contact number failed to reveal a new listing for the Respondent.

Order of Cancellation

6. That Section 8.E(2) of the Act provides, inter alia, that if the Secretary of State finds that any registrant or applicant for registration is no longer in business as a dealer or cannot be located after reasonable search, the Secretary of State may by order cancel the registration or application.
7. That the Department has determined that the Respondent has ceased to do business as a dealer in the State of Illinois.
8. That it is in the public interest to enter an order which cancels the dealer registration of the Respondent in the State of Illinois.

NOW THEREFORE IT IS HEREBY ORDERED: That the dealer registration of the Respondent in the State of Illinois is hereby cancelled.
