ORDER OF PROHIBITION

WHEREAS, a Temporary Order of Prohibition was issued by the Secretary of State on May 24, 2017, and a Corrected Temporary Order of Prohibition on June 6, 2017, which temporarily prohibited **James Fraizer** from offering or selling securities and rendering investment advice in or from the State of Illinois until further order of the Secretary of State or his duly authorized representative;

WHEREAS, pursuant to section 11.F of the Illinois Securities Law of 1953 [815 ILCS 5] (the "Act"), the failure to request a hearing within thirty (30) calendar days of the entry of the Temporary Order shall constitute an admission of any acts alleged therein and constitute a sufficient basis to make the Temporary Order final;

WHEREAS, the Respondent(s) failed to request a hearing on the matters contained in the Temporary Order within thirty (30) calendar days of the entry of said Temporary Order and the Respondents are hereby deemed to have admitted the facts alleged in the Temporary Order;

WHEREAS, the Secretary of State, by and through his duly authorized representative, has adopted the Findings of Fact contained in the Temporary Order as the Secretary of State's Findings of Fact as follows:

**FAILURE TO RESPOND TO ILLINOIS SECURITIES DEPARTMENT SUBPOENA
DUCES TECUM**

1. James Fraizer ("Respondent") is an individual with the last known addresses of 6 Champion Trail, San Antonio, TX 78258; 515 Congress Avenue, Suite 260, Austin, TX 7870; 521 W. Wilshire Blvd., Suite 101, Oklahoma, OK 73116; 2003 My Anns Hill, San Antonio, TX 78258; and 421 NW 13th St, Suite 210, Oklahoma City, OK 73103.
2. A Subpoena Duces Tecum was mailed, certified mail, by the Department on March 7, 2016 to Respondent's last known addresses- 6 Champion Trail, San Antonio, TX 78258; 515 Congress Avenue, Suite 260, Austin, TX 7870; 521 W. Wilshire Blvd., Suite 101, Oklahoma, OK 73116; 2003 My Anns Hill, San Antonio, TX 78258; 720 W. Wilshire, Ste 115, Oklahoma City, OK 73116; and 421 NW 13th St, Suite 210, Oklahoma City, OK 73103- in the matter of File No. 1600828.
3. Attached to the Subpoena Duces Tecum was a Schedule "A" listing the documents or information to be produced.
4. The due date for the Subpoena Duces Tecum was March 31, 2017.
5. Respondent failed to comply with the Subpoena Duces Tecum and failed to provide to the Department the requested documents or information on March 31, 2017 or any time thereafter.
6. The Subpoena Duces Tecum was issued pursuant to Section 11.D(1) of the Illinois Securities law of 1953 (815 ILCS 5/1 et. seq.) (the "Act").
7. Section 11.D of the Act states, inter alia, that the Secretary of State or a person designated by him or her may require by subpoena the production of any books and records, papers, or other documents which the Secretary of State or a person designated by him or her deems relevant or material to the inquiry.

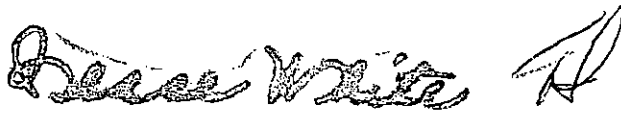
8. Respondent failed to produce any of the documents requested by the due date, or any day thereafter, that were subpoenaed by the Department pursuant to the authority granted under Section 11.D(1) of the Act.
9. By virtue of the foregoing, Respondent's failure to respond to the Subpoena Duces Tecum by the due date impeded designees of the Secretary of State from conducting an investigation under Section 11.D (1) of the Act.

NOW THEREFORE IT IS HEREBY ORDERED THAT: pursuant to the authority granted by Section 11.F of the Act, Respondent James Fraizer is PROHIBITED from rendering investment advice and from offering or selling securities in or from this State until the further Order of the Secretary of State.

NOTICE: Failure to comply with the terms of this Order shall be a violation of Section 12.D of the ACT. Any person or entity that fails to comply with the terms of this Order of the Secretary of State, having knowledge of the existence of this Order, shall be guilty of a Class 4 felony for each offence.

This is a final order subject to administrative review pursuant to the Administrative Review Law [735 ILCS 5/3-101 et seq.] and the Rules and Regulations of the Act (14 Ill. Admin. Code, Ch. 1 Sec. 130.1123). Any action for judicial review must be commenced within thirty-five (35) days from the date a copy of this Order is served upon the party seeking review.
