General Partner. GP Softech LLC is the General Partner of Slip Doctors. Greg Cohen is a limited partner of Slip Doctors and manages the day-to-day operations.

2. Respondent Slip Doctors offers prospective customers business opportunities, which include products, marketing materials, provider lists, and training; allowing prospective customers of Slip Doctors to open small businesses and engage in the business of treating floors and other surfaces to prevent slips and falls.
3. Illinois defines a business opportunity as a contract or agreement, between a seller and purchaser, express or implied, orally or in writing, wherein it is agreed that the seller or a person recommended by the seller shall provide to the purchaser any product, equipment, supplies or services enabling the purchaser to start a business when the purchaser is required to make a payment to the seller or a person recommended by the seller and the seller represents directly or indirectly, orally or in writing that the seller will provide or assist the purchaser in finding outlets or accounts for the purchaser's products or services; the seller guarantees that the purchaser will derive income from the business which exceeds the price paid to the seller; or the seller will provide a marketing plan. Illinois Business Opportunities Sales Law of 1995 [815 ILCS 602/5-5.10] the ("Act").
4. Respondent Slip Doctors entered into a Consent Order of Censure on February 10, 2017 for violating Section 5-25 of the Act for selling unregistered business opportunities during the period of August 2015 through February 10, 2017 when the Order was issued.
5. The February 10, 2017 Order stated that:

**"SoftTec Products, L.P. d.b.a. Slip Doctors SHALL refrain from offering or selling any and all business opportunities within the State of Illinois until such time as it has properly registered with the Illinois Secretary of State in accordance with the Illinois Business Opportunities Sales Law of 1995."**
6. Respondent Slip Doctors became registered in Illinois to offer and sell business opportunities on July 11, 2017.
7. However, subsequent to the Consent Order and prior to being registered with the State of Illinois, Respondent Slip Doctors has represented to the Department that they only offered and sold two (2) business opportunities to Illinois residents on February 24<sup>th</sup> and February 28<sup>th</sup> 2017 in violation of the Act and the Consent Order.
8. Section 5-25 states, *inter alia*, that it is unlawful for any person to offer or sell any business opportunity in this State unless the business opportunity is registered under this Law or is exempt under Section 5-10 of this Law.

9. Section 5-95 states, *inter alia*, that no person shall, either directly or indirectly, offer or sell any business opportunity without registration under this Act unless the person offering or selling the opportunity is exempt under the Act.

**CONCLUSIONS OF LAW**

By means of Stipulation, Respondent Slip Doctors acknowledge and admit to the facts alleged in this Consent Order. Respondent Slip Doctors submit to the jurisdiction of the Secretary of State, and acknowledge and admit to the following Conclusions of Law:

1. Respondent Slip Doctors has violated Sections 5-25 and 5-95 of the Illinois Business Opportunities Sales Law of 1995.

**UNDERTAKINGS**

WHEREAS, by means of the Stipulation, Greg Cohen, on behalf of Respondent Slip Doctors has acknowledged and agreed to the following:

1. Respondent Slip Doctors agree to a fine of \$1,000, representing \$500 fine for each sale, in accordance with Section 5-65(4) for violations of Sections 5-25 and 5-95 of the Illinois Business Opportunities Sales Law of 1995, made payable to the Office of the Secretary of State, Securities Audit and Enforcement Fund located at 69 West Washington, Suite 1220, Chicago, IL 60602 and referencing case # 1800044 within 10 days of this Order.
2. Respondent Slip Doctors agree that Slip Doctors shall only offer and/or sell business opportunities within the State of Illinois in accordance with and pursuant to the Illinois Business Opportunities Sales Law of 1995.

NOW THEREFORE, IT IS HEREBY ORDERED THAT:

1. SoftTec Products, L.P. d.b.a. Slip Doctors is FINED \$1,000, made payable to the Office of the Secretary of State, Securities Audit and Enforcement Fund located at 69 West Washington, Suite 1220, Chicago, IL 60602 and referencing case # 1800044 within 10 days of this Order.
2. SoftTec Products, L.P. d.b.a. Slip Doctors SHALL only offer and/or sell business opportunities within the State of Illinois in accordance with and pursuant to the Illinois Business Opportunities Sales Law of 1995.

Both the Temporary Order of Suspension dated January 24, 2018, and the Notice of Hearing dated February 22, 2018, are dismissed.


