WHEREAS, Respondents Alex Field and Edward Renko on the 17th day of January 2018 and Respondent Gary Fiskin on the 23<sup>rd</sup> of January, 2018 executed a certain Stipulation to Enter Consent Order (the "Stipulation"), which hereby is incorporated by reference herein.

WHEREAS, by means of the Stipulation, the Respondents have admitted to the jurisdiction of the Secretary of State and service of the Amended Notice of Hearing of the Secretary of State, Securities Department, dated August 24, 2010, in this proceeding (the "Notice") and Respondent have consented to the entry of the Consent Order.

## Consent Order of Prohibition

WHEREAS, by means of the Stipulation, the Respondents acknowledge that the following allegations contained in the Notice of Hearing shall be adopted as the Secretary of State's Findings of Fact:

- a. Mega Entertainment Group II, LLC ("Mega") is an Illinois Limited Liability Corporation.
- b. Respondent Alex Field, ("Field"), is an individual who maintains his last known residence address at 700 Greenwood, Northbrook, Illinois 60062.
- c. Respondent Edward Renko, ("Renko"), is an individual who maintains his last known residence address at 711 Greenwood, Northbrook, Illinois 60062.
- d. Respondent Gary Fishkin, ("Fishkin", collectively with Respondent Field and Respondent Renko "Respondents") is an individual who maintains his last known residence address at 688 Greenwood, Northbrook, Illinois 60062, and his last known business address at 3100 Dundee Road, Suite 107, Northbrook, Illinois 60062.
- e. That on February 20, 2009 a Temporary Order of Prohibition was entered in the matter of Capital Development Group LLC, et al. (0900017), that prohibited Alex Field, Edward Renko and Gary Fishkin from offering or selling securities in or from the State of Illinois until further Order of the Secretary of State.
- f. That Respondents Alex Field, Edward Renko and Gary Fishkin were sent copies of the Temporary Order of Prohibition in case number 0900017 on:
  - 1) February 20, 2009, via USPS Certified Mail, to 3100 Dundee Road, Suite 107, Northbrook, Illinois 60062, return receipt requested. The respective USPS form number 3811 (green card) was signed and receipted for by Gary Fishkin on behalf of himself, and returned to the Department by the USPS.
  - 2) February 24, 2009, via USPS Certified Mail, to 3100 Dundee Road, Suite 107, Northbrook, Illinois 60062, return receipt requested. The respective USPS form number 3811 (green card) was signed and receipted for by Gary Fishkin on behalf of Edward Renko, and returned to the Department by the USPS.
  - 3) February 24, 2009, via USPS Certified Mail, to 3100 Dundee Road, Suite 107, Northbrook, Illinois 60062, return receipt requested. The respective USPS form number 3811 (green card) was signed and receipted for by Gary Fishkin on behalf of Alex Field, and returned to the Department by the USPS.

- g. That Respondents Alex Field, Edward Renko and Gary Fishkin, in writing on March 16, 2009 "on behalf of all of the Respondents "requested "a hearing regarding the Temporary Order of Prohibition and each of them individually signed said request which was transmitted to the Department.
  - h. That subsequent to receiving the Temporary Order of Prohibition, Respondents offered securities to at least one Illinois Resident and also offered securities from the State of Illinois.
  - i. That Section 12.D of the Act provides, inter alia, that it shall be a violation for any person: to fail to comply with the terms of any Order of the Secretary of State issued pursuant to Section 11 hereof.
  - j. That said offer of securities by Respondents constitutes a willful failure to comply with the Order entered on February 20, 2009.
  - k. That by virtue of the foregoing, the Respondents have violated Section 12.D. of the Act.
8. Acknowledge, that the following shall be adopted as the Secretary of State's Conclusion of Law:
- That by virtue of the foregoing Respondents have violated Sections 12.D, of the Act.
9. Acknowledge and agrees that they desire to resolve this matter absent further administrative action.
10. Acknowledge and agrees that Field, Gary Fishkin and Edward Renko, shall be permanently PROHIBITED from offering or selling securities in or from Illinois.
11. Acknowledge and agrees that this Stipulation is entered into freely and voluntarily and that no employee or representative of the Secretary of State has made any promise or representation to induce its execution, including without limitation, any promises or representations with regard to:
- a. Civil or criminal liability arising from the facts underlying this matter;
  - b. Immunity from any such civil or criminal liability; or
  - c. Immunity from further action by the Securities Department with respect to violations not connected with the facts underling this matter.

WHEREAS, the Secretary of State, by and through his duly authorized representative, has determined that the matter related to the aforesaid formal hearing may be dismissed without further proceedings.

NOW THEREFORE IT SHALL BE AND IS HEREBY ORDERED:

1. That Respondents Alex Field, Gary Fishkin and Edward Renko shall be permanently PROHIBITED from offering or selling securities in or from Illinois.
2. That the formal hearing in this matter is dismissed without further proceeding.
